**3. Plan of Dissolution:**

The following Plan for Complete Liquidation and Dissolution (the "Plan") of FRIENDS OF TEMPLE BETH-EL JERSEY CITY A NJ NONPROFIT CORPORATION, a New Jersey nonprofit corporation, (the "Corporation") is intended to accomplish the complete liquidation and subsequent dissolution of the Corporation.

1.Approval of the Plan. The Plan shall become effective upon its approval and adoption by written consent of the Board of Trustees of the Corporation (the "Board") in conformity with N.J.S.A. 15A:12-5 and N.J.S.A 15A:6-7(c) (Action without a meeting).

2.Payment of Obligations. The Corporation shall pay or make provision for the payment of all obligations of the claims against the Corporation, including unascertained or contingent liabilities and expenses (the "Obligations"). Such disposition of the Obligations shall be consummated as expeditiously as practicable.

3.Distribution of Assets. In accordance with the Order of the Superior Court of New Jersey, Chancery Division: Hudson County, Docket No. HUD-C-10-24 filed on March 1, 2024, on or before March 21, 2024, the Corporation shall distribute any and all remaining funds that were raised and held for the Kadimah! project and are in the Corporation's possession, to the Congregation of Temple Beth El of Jersey City ("Congregation") on the condition that the they be utilized to pay for or offset the costs of rehabilitation of the Congregation's Social Hall/Lower Level of the building located at 2419 John F. Kennedy Blvd., Jersey City, NJ 07304. Any remaining funds that were not raised or held for the Kadimah! project shall be donated in compliance with applicable Federal and

The Board shall carry out and consummate this Plan and shall have power to adopt all resolutions, execute all documents, and file all papers, and take all other action they deem necessary or desirable for the purpose of effecting the complete liquidation of the Corporation's assets, winding-up its business and affairs, and effecting its dissolution.
