The Friends of Temple Beth-EI's mission is to provide for the capital needs of Congregation Temple Beth-EI, including raising funds sufficient to repair and renovate the present synagogue building and to provide for the ongoing costs of structural maintenance.

Commenced restoration of new roof (anticipated total cost \$380,000). The distinctive synagogue building houses a magnificent sanctuary whose stately beauty has inspired visitors for generations. The 4,000 sf roof protecting the structure is in need of replacement. The situation was exacerbated by the theft of copper from the walls of the dome in 2011. The theft further exposed the interior plaster dome to the elements. Fundraising by the Friends of Temple Beth-EI will enable it to provide grants to the congregation to complete its roof replacement in 2016, and protect the interior of the building from further deterioration.

4b (Code:) (Expenses \$ 11,469 including grants of \$) (Revenue \$ 11,469)

A residential structure, built in the early 20th Century, occupied the lot adjacent to the synagogue structure. The congregation purchased the lot and the building, one floor of which was then used as a dental office, in 1953, with the intention of demolishing the house and expanding the then overcrowded religious school. During 2015, funds raised by the Friends of Temple Beth-EI and granted to the congregation finally enabled the demolition of the structure, removal and proper disposal of asbestos from the structure and the first phase of remediating the impact of the leaking heating oil tank that served the structure.

The interior of the synagogue is in need of substantial infrastructure re-work, disabled access to all floors, renovation of stained glass, fire and security systems and general reconfiguration of the space to allow more flexible use while maintaining the grandeur of the sanctuary space. (anticipated total project cost \$3.2 million, architect's fees \$360,000) The congregation approved a preliminary design concept for interior of Temple. Grants from the Friends of Temple Beth-EI during 2015 enabled the congregation to engage an architectural firm which produced preliminary drawings and will eventually implement the full renovation.
